Sub: Intimation under Regulation 30 read with Regulation 31(A)(8) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("SEBI Listing Regulations") following the receipt of a request for reclassification from the promoter seeking reclassification

The Company has this day received a letter dated 16 September, 2025 ("Request Letter") from M/s. Yanmar Coromandel Agrisolutions Private Limited (YCAS) ("Outgoing Promoter"), classified as a part of Promoter Group of the Company, seeking reclassification from the 'Promoter and Promoter group' category to 'Public' category under Regulation 31A of the SEBI Listing Regulations.

The reclassification request is made pursuant to a change in the shareholding of YCAS. Currently, YCAS forms part of the promoter group by virtue of being an associate company of Coromandel International Limited (CIL), one of the promoters of the Company.

We are informed that the shareholding of Coromandel International Limited (CIL) in YCAS has reduced from 40% to 10.60%, on account of a fund infusion of Rs.149.72 Crores by Yanmar Asia (Singapore) Corporation Pte Ltd (Yanmar Singapore) on 27 September, 2024. Further to the allotment of 11,09,00,741 equity shares of face value Rs.10/- each by YCAS to Yanmar Singapore, YCAS ceases to be covered under the definition of Promoter group as specified in 2(pp) of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 (by virtue of CIL holding less than 20% of the equity share capital of YCAS) and hence has requested its name to be removed from the Company's Promoter Group list.

Kindly note that as on the date of the Request Letter, YCAS, Outgoing Promoter does not hold any shares in the Company.



Sub: Request for reclassification from "Promoter and Promoter Group" Category to "Public" category (Nil shares held by Yanmar Coromandel Agrisolutions Private Limited (YCAS) as on date of this request) of Cholamandalam Investment and Finance Company Limited ("Company") in accordance with Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended from time to time ("Listing Regulations")

### 1. Background and Rationale

- 1.1 We, Yanmar Coromandel Agrisolutions Private Limited (YCAS), are writing this letter to inform you of our intention to be re-classified to public category in accordance with Regulation 31A of the Listing Regulations, since at present we are classified as Promoter Group in your Shareholding Pattern.
- 1.2 The above request is pursuant to change in the shareholding of Coromandel International Limited (CIL) in YCAS from 40% to 10.60%, on account of a fund infusion of Rs.149.72 Crores by Yanmar Asia (Singapore) Corporation Pte Ltd (Yanmar Singapore) on September 27, 2024. Further to the allotment of 11,09,00,741 equity shares of face value Rs.10 each by YCAS to Yanmar Singapore, YCAS does not fall under the definition of Promoter group specified in 2(pp) of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 (by virtue of CIL holding less than 20% of the equity share capital of YCAS).
- 1.3 We understand that the equity shares of the Company are presently listed on BSE Limited and National Stock Exchange of India Limited.
- 1.4 As per the latest shareholding pattern of the Company, we are disclosed as part of the "promoter group" category of the Company.
- 1.5 As on the date of this letter, we hold nil shares of the Company.

#### 2. Request for Re-Classification

- 2.1 In culmination of the above, we request the Board of Directors to take on record our request for re-classification to public category in accordance with Regulation 31A of the Listing Regulation and take all the necessary steps in this regard.
- 2.2 As required under Regulation 31A (3)(b) of the Listing Regulation, we hereby confirm that, neither we or nor any person related to us:

- a) Together, hold more than 10% of the total voting rights in the Company;
- b) exercise control over the affairs of the Company directly or indirectly;
- c) have any special rights with respect to the Company through formal or informal arrangements including through any shareholder agreements;
- d) are represented on the board of directors (including not having a nominee director) of the Company;
- e) are acting as a key managerial personnel in the Company;
- f) are classified as 'willful defaulter' as per the guidelines issued by the Reserve Bank of India; and
- g) have been categorized as a fugitive economic offender.
- 2.3 We further confirm that we do not act in concert with the Promoter/ Promoter Group of the Company.
