Sub: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 – Change of Statutory Auditors

As per the RBI circular dated 27th April, 2021 on Guidelines for appointment of statutory auditors of Banks and NBFCs, the Company will need to appoint statutory auditors for a continuous period of three years, subject to satisfaction of eligibility norms and independence criteria prescribed. Further, the statutory audit should be conducted under joint audit of a minimum of two audit firms.

In view of the above Guidelines, the Board of Directors of the Company, vide resolutions dated 21st June, 2021 has:

- (i) Taken note of the letter dated 21st June 2021 received from M/s. S.R. Batliboi & Associates LLP, current auditors of the Company communicating their intention to resign as statutory auditors of the Company since they have completed four years of continuous audit and are ineligible to continue as auditors beyond 30th September, 2021 and
- (ii) Considered and recommended for approval of the shareholders at the ensuing 43rd Annual General Meeting (AGM) scheduled on 30th July, 2021, the appointment of M/s. Price Waterhouse, Chartered Accountants LLP and M/s. Sundaram & Srinivasan, Chartered Accountants, as the Joint Statutory Auditors of the Company for three years from the conclusion of 43rd AGM up to the conclusion of 46th AGM.

Information as required under Regulation 30 - Part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 is annexed herewith.

Sundaram & Srinivasan, Chartered Accountants:</p> <p>Pursuant to the aforesaid RBI circular since SRB will be ineligible to continue as statutory auditors of the Company beyond 30th September, 2021 and the statutory audit of the Company should be conducted under joint audit of a minimum of two audit firms, the Board of Directors in compliance with the RBI circular have considered, approved and recommended the appointment of M/s. Price Waterhouse Chartered Accountants LLP and M/s. Sundaram & Srinivasan, Chartered Accountants as Joint Statutory auditors for the approval of shareholders.</p>
